

### Letter from the President/CEO

For over 30 years, RDA has contributed to our community's vision for its own future. The cover of this report includes projects that have been funded, but are not yet complete. RDA has the flexibility to fund a wide range of projects, from wet lands restoration at Nahant Marsh to a public park honoring Dr. Martin Luther King, Jr. From financial literacy development at Junior Achievement to artistic expression at the Ballet Quad Cities. In this report you will see many of the projects RDA has supported, meet our Board members, and see our overall financial contribution to the Quad Cities.

Since 1991, the Regional Development Authority (RDA) has awarded over \$85 million through 4,511 grants. This major funding stream to benefit Scott County people is made possible by Iowa's gaming legislation that establishes a local nonprofit organization as a gaming license holder with a casino operating partner. In this arrangement, RDA is the Qualified Sponsoring Organization (QSO) – or license holder – for Rhythm City Casino Resort in Davenport, Iowa. By contract, RDA receives a share of the gaming revenue generated at Rhythm City Casino. In 2022, through this arrangement RDA was able to award \$5,028,663 in grant funding. RDA's contract with Rhythm City Casino also secured another \$2.2 million in 2022 for the City of Davenport and the Downtown Davenport Partnership.

RDA is led by an 18 member volunteer Board of Directors who oversees our operations, reviews all grant applications each year, and decides how to allocate funds to make the biggest impact. It's not a small task, and so I am always grateful that our Board members take on that work. In this report, you can learn about the experiences and interests of the members of RDA's Board.

RDA Board members often say that reading and scoring grant applications every year helps them to learn more about our community... and gain a far greater appreciation for the work of the nonprofit sector. RDA makes grants that impact our Quad Cities region through economic development, human services, arts, culture, and education projects. Our grants support capital development, grassroots volunteer efforts, innovative approaches to community challenges, and a wide range of community projects and events. 


# **Dana Wilkinson**


# **Ballet Quad Cities**


## **Nahant Marsh**


# RDA and Casino Partnership
