Letter from the RDA President/CEO

After completing our 64th grant-making cycle in 2023, the Regional Development Authority (RDA) passed the \$90 million mark for grants awarded! Over this last 32 years (since 1991), RDA Board members have evaluated 6,363 grant applications. We have fully or partially funded 4,649 – or 73% of the applications we received. The 2024 RDA Annual Report recognizes just a few of those community partners who, year after year, make such a big difference in our community. The cover displays many, but certainly not all of the organizations, that we count as partners in our community. Every year, RDA supports between 100 and 150 organizations that work to make our community better. We can be grateful that there are so many people who care deeply and put that caring into action.

This milestone calls for a moment of reflection about the impact of those funds... and we can celebrate so many types of community impact:

- helping build new physical structures and renovate existing buildings;
- responding to emergency situations;
- supporting local cultural and entertainment events;
- purchasing equipment and supplies for essential programs;
- supporting the work of grassroots volunteer groups to promote civic engagement;
- providing operational funds to cover temporary funding gaps;
- providing funds to help expand an organization’s capacity;
- supporting innovative approaches to community challenges; and
- providing local matching dollars for national and federal grants to bring new money into our regional economy.

This significant funding stream for Scott County, Iowa is made possible by Iowa’s gaming legislation that establishes a local nonprofit organization as a gaming license holder with a casino operating partner. In this arrangement, RDA is the Qualified Sponsoring Organization (QSO) – or license holder – with Rhythm City Casino Resort in Davenport, Iowa (owned by an Iowa based company, Elite Casinos Resorts). By contract, RDA receives a share of the gaming profits generated at Rhythm City Casino Resort. In 2023, through this arrangement, RDA was able to invest \$4,778,910 of this shared profit into the community. RDA’s contract with Rhythm City Casino also secured an additional \$1.9 million in 2023 for the City of Davenport and the Downtown Davenport Partnership.

RDA is led by an 18-member volunteer Board of Directors who oversees our operations, reviews all grant applications each year, and does the difficult task of deciding how to allocate funds to make the biggest impact. It’s not a small task, and so I am always grateful that our Board members take on that work. In this report, you can learn about the RDA’s broad community impact, as well as about the members of RDA’s Board who quietly make such a big difference!


Sue Daley, Treasurer of the Board





Hilltop Campus Village




The Hilltop Campus Village is excited to move forward with its offices in Davenport. Acquired in 2021, the HCV will be moving forward this winter with their remodeling project to upgrade their offices to provide affordable office space to local nonprofits and entrepreneurs. This project will also include the creation of upgraded meeting space to host community and business meetings.


EveryChild

EveryChild's Community Doulas provide prenatal & postnatal education and labor and delivery support for expectant families with a focus on attachment & bonding. Starting at the beginning of the third trimester, our doulas teach new parent skills, familial health support, building of advocacy skills, early attachment and bonding, & acclimating to home life to give families their best start!



Doulas are trained to provide emotional and informational support to women during pregnancy, labor, birth, and in the immediate postpartum period.

EveryChild's Community Doulas work with families to reduce stress during pregnancy, labor and birth - leading to better birth outcomes and stronger family bonding and attachment.



Azubuiké African American Council for The Arts

In June of 2023, Azubuiké African American Council for the Arts launched the inaugural year of the Pulling Focus Film Festival, an annual celebration of film and culture that focuses on enriching the lives of Quad Cities residents by presenting unique film-watching experiences framed through the lens of African American and Black Diasporic voices.



100 Black Men Quad Cities

100 Black Men Quad Cities, Inc is committed to empowering individuals to meet challenging society needs and developing life skills to all youth to bridge the gaps to success on an educational playing field!



City of Blue Grass

Black Bear Park family restroom (with baby changing stations) and storm-shelter facility” mission to encourage more families to enjoy the outdoors by visiting our City Park that is equipped with a play-station playground unit, shelter with picnic tables and volleyball court that is adjacent to Liberty Trail for easy access.



Family Resources

With RDA funding, Family Resources was able to provide services to 530 survivors, which amounted to approximately 12,142 shelter nights. Services that were provided to survivors in the program included trauma informed care to assist survivors heal, collaboration with other programs to meet the individual needs of each survivor, advocacy, housing assistance, employment assistance, and financial assistance.




STEAM on Wheels

STEAM on Wheels introduces Quad Cities students to robotics with scholarships available for Scott County residents. Our 2024 sessions offer hands-on learning, mentorship from industry experts, and endless possibilities in robotics and STEM.



River Action

River Action is exploring new avenues of revenue, funding, memberships, leadership development and succession—all parts of capacity building—as it continues its mission of fostering the environmental, economic, and cultural vitality of the Mississippi River and its riverfront in the Quad City Region.



Quad Cities Veterans Outreach Center

The funding provided by the RDA helped purchase a refrigerated van that has significantly enhanced support for Veterans. QC Veteran Outreach can now acquire larger quantities of food, including refrigerated items, and offer a more extensive variety of food. Their services now reach over 3,000 Veterans, and the newly acquired van has proven to be indispensable, operating continuously to meet the growing demand.



TMBC at the Lincoln Center



The RDA grant helped to bridge TMBC's start-up operational costs, allowing us to expand and enhance our services for the Black community. This grant played a pivotal role in sustaining and advancing our mission, enabling us to reach more individuals and address pressing issues within the community. RDA has empowered us to make a more substantial and lasting difference in the lives of those we serve.




Iowa Legal Aid

Preventing homelessness by providing no-cost legal services to approximately 1,500 low-income Scott County renters at risk of eviction.



Quad Cities Open Network

The Quad Cities Open Network is working to address community gaps together with partner organizations. This year they have used data collected through the shared emergency assistance program offered to its members to identify root causes for the requests received. Priorities identified were housing and behavioral health. Together the partner agencies are working on ways to effectively collaborate and deploy main-stream eviction diversion dollars.



Freight House Farmers Market

Music at the Market allows local youth and professional musicians to perform regularly in front of a diverse audience at the Freight House Farmers Market. The funding for additional sound equipment enabled the stage to host various musical events, from solo artists to large bands.



Common Chord

In the InTune Music Mentoring Program, mentors explore students' musical passions while building mentoring relationships. The second year of a three-year pilot phase saw the program expand to new locations and reach more students.



Kinna's House of Love

Kinna's House of Love promotes love and inclusiveness to empower women and children. They offer a safe place for healing and support through community gatherings and programs for children and teens that may be at risk for physical or sexual abuse. Kinna's Corner is expecting to expand to be able to serve 700 people per year and keep kids as safe as possible.
